Steinberger Sound Corp. (Steinberger) hereby warrants, to the original retail purchaser only, that this instrument is free from defects in materials and workmanship, as follows.

DURATION: The lifetime of the original purchaser.

EXCLUSIONS: This warranty shall not apply to strings, tone, or normal wear of the plating, electrical components or frets. This warranty shall not apply to instruments which have been subjected to accident, abuse, misuse, alteration or neglect, including exposure to extremes of heat, cold or humidity.

CONDITIONS: This warranty shall apply provided that:

1. the buyer completes and returns the attached warranty card within ten (10) days of purchase;

2. the buyer gives prompt notice of any claimed defect, and explains the nature of such defect, either in writing or by telephone to the Manager of Steinberger's Customer Service Department at Steinberger Sound Corp., 122 S. Robinson Avenue, Newburgh, NY 12550. (914) 565-4005.

3. the model number and serial number on both the registration card and the instrument have not been altered; and

4. the buyer returns the instrument claimed to be defective to Steinberger, at the buyer's expense and risk of loss or damage during shipment.

REMEDY: Steinberger will repair the instrument claimed to be defective, with materials and processes in use at the time of repair. For the first two (2) years from the date of original retail purchase, such repair shall be performed free of charge. Thereafter, Steinberger will perform such repair free of charge for material, but shall charge for service and labor at rates in effect at that time.

LIMITATIONS ON DAMAGES: Steinberger shall not be liable for damages arising out of the manufacture, sale, delivery or use of this instrument in excess of the purchase price paid therefor, nor for any property, incidental or consequential damages, including loss of use or profits. In the event of damage or loss by fire or theft while in the possession of Steinberger, its liability shall be limited to replacement with a new instrument of the same or most similar available style. Steinberger shall not in any event be liable for any excess or collector value.

Any action for breach of this warranty or any other action in connection with the sale of this instrument must be commenced within one (1) year after such cause of action arises.

THIS LIMITED WARRANTY IS EXCLUSIVE AND IS MADE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
